It is an LLC whose 17. 14 primary place of business is located in San Diego. 15 Provest, LLC employed or contracted with Williams and/or A-1 Proserv for the service of 16 18. process upon the Plaintiffs. 17 18 FIRST CAUSE OF ACTION: 19 **CLAIM FOR ABUSE OF PROCESS** 20 19. Plaintiff re-alleges and incorporates by reference, as if verbatim, each and every 21 paragraph preceding as though set forth in full herein. 22 20. Each of the subject Affidavits of Service swore that Williams had personally served the 23 Plaintiffs with process in the Florida Action. 24 21. Both of these Affidavits of Service were false. 25 22. Williams never served process upon either Plaintiff at any time. 26 Williams' Affidavits of Service were false, fraudulent, and perjurious. 23. 27 28

- 25. The Defendants, acting with the imprimatur of the court, committed an intolerable act Defendant Williams lied in his sworn statements that he personally served Mr. Randazza and Mrs. Randazza.
- 7 26. Defendants misused the legal process by making a sworn, perjurious statement before a California notary.
- The Defendants further misused the legal process by filing a perjurious document with the Court—the specific perjury being a willfully false statement that Defendant Williams had personally served each of the plaintiffs with process in a Florida action, when he had served neither of them.
- 13 28. The requisite element of malice or ulterior motive should be inferred from the 14 Defendants' willful abuse of the process.
 - 29. If such inference fails, malice specifically exists in that Defendants acted with malice and conscious disregard for the rights of Plaintiffs in that their ulterior purpose in misusing the legal process was to earn process server fees and notarization fees while not executing their lawful duties to actually serve process upon the Plaintiffs.
 - 30. Furthermore, this action was taken either with the conscious intent of causing the Plaintiffs to default in the Florida Action or with reckless disregard as to the Plaintiffs' rights to be informed of the action against them.
- 22 31. As a proximate result of Defendants' misuse of the legal process, Plaintiffs suffered damages generally.
- 24 32. The depravity of the Defendants' misconduct fulfills all the requirements for the award of exemplary damages.
- 26 33. On information and belief, the Defendants have engaged in a pattern and practice of falsifying service of process documents and thus should be punished severely in order to deter such conduct in the future.

1 SECOND CAUSE OF ACTION CIVIL CONSPIRACY 2 Plaintiff re-alleges and incorporates by reference, as if verbatim, each and every 34. 3 paragraph preceding as though set forth in full herein. 4 The Defendants agreed, implicitly or explicitly, to commit the acts herein alleged. 35. 5 The Defendants jointly operated to perpetrate the wrongful acts complained of herein. 36. 6 The Defendants equally profited from the wrongful acts complained of herein. 37. 7 The Defendants are jointly and severally liable for each of the wrongs. 38. 8 9 THIRD CAUSE OF ACTION **VICARIOUS LIABILITY** 10 Plaintiff re-alleges and incorporates by reference, as if verbatim, each and every 39. 11 12 paragraph preceding as though set forth in full herein. 40. Provest, LLC is vicariously liable for Defendant Williams' misdeeds as provided for 13 14 under Cal Bus. & Prof. Code §22356. WHEREFORE, Plaintiffs demand judgment against Defendants jointly and severally as 15 16 follows: 17 1. For general damages in the amount of \$50,000. 2. For punitive damages, as authorized by Cal. Civ. Code. §§ 3294 and 1427-28 in the 18 19 amount of \$250,000. 20 3. For a declaration from this Court that Williams' authorization to serve process in this State should be revoked immediately, that A-1 Proserv, LLC, should be similarly barred from the 21 process server profession in this state, and that the Defendants be enjoined from further 22 23 engagement in the process server profession. 24 4. For the costs of suit herein incurred. 25 26 /// 27 /// 28 ///
